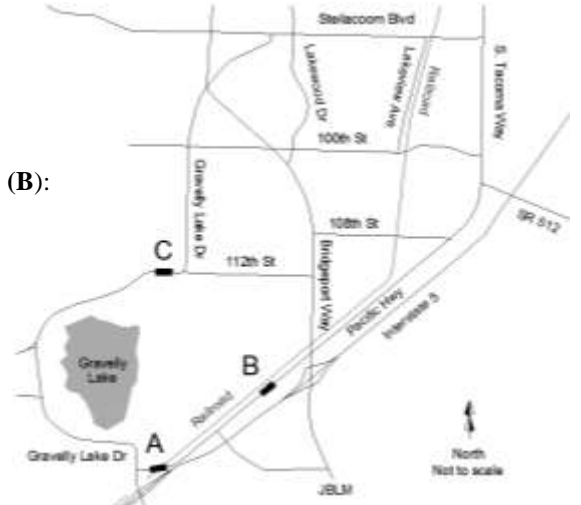

# OVERSIZE LOAD PERMIT CONDITIONS OF APPROVAL

**CITY OF LAKEWOOD USE ONLY** (*check all that apply*):

- Use caution at all signals due to height of load.
- Railroad Bridge located on Pacific Hwy just east of Gravelly Lake Drive requirements (A):
  - Maintain constant slow speed, maximum 5 mph
  - Drive over southern most travel lane of bridge
  - No other vehicles on bridge structure with transportation vehicle
  - No shifting gears allowed on the bridge
  - Use caution
- Clover Creek Bridge on Pacific Hwy, NE of Clover Creek Dr, requirements (B):
  - Maintain constant slow speed
  - Maximum speed 10 mph, drive over center of bridge
  - No other vehicles on bridge structure with transportation vehicle
  - No shifting gears allowed on the bridge
  - Use caution
- Clover Creek Bridge on Gravelly Lake Drive SW requirements (C):
  - Maintain constant slow speed
  - Maximum speed 5 mph, use southernmost lanes
  - Close bridge to other traffic during overload crossing
  - No shifting gears allowed on the bridge
  - Use caution

- Provide two pilot cars in front of load to stop traffic from left/right & oncoming approach at intersections when making turning movements; a third pilot car is still required behind oversize load or contact Lakewood Police Department (24 hours in advance) for police availability to escort the load at 253-830-5090 or 253-606-6012 - Sgt. John Fraser.

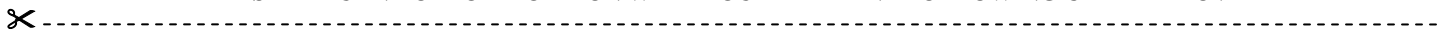

1. A copy of this permit must be present in the vehicle at all times. All work must conform 100% to the terms of this permit.
2. In accepting this permit, the Grantee, his successors and/or assigns, agree to protect the City and save it harmless from all claims, actions or damages of every kind and description which may accrue to or be suffered by any person or persons, corporation or property by reason of the performance of any such work, character of materials used or manner of installation, maintenance and operation or by the improper occupancy of rights-of-way or public place or public structure, and in case any suit or action is brought against the said City for damages arising out of or by reason of any of the above clauses, the petitioner, his successors or assigns will upon notice to him or them of commencement of such action, defend the same at his or their own sole cost and expense and will satisfy judgment after the said suit or action shall have finally been determined if adverse to the City.
3. The Public Works Director may revoke, annul, change, amend, amplify, or terminate this Permit or any of the conditions herein enumerated if Grantee fails to comply with notices given or if the utility herein granted is not installed or operated and maintained in conformity herewith or alt all or for any cause or reason whatsoever or due to construction projects affecting proposed routes.
4. In accepting this Permit, the Grantee, his successors and/or assigns, agree that any damage or injury done to the property of the Grantee or any expense incurred by him through the operation of a contractor, working for the City, or of any City employee shall be at the sole expense of the Grantee, his successors and/or assigns, and shall contact the City immediately at (253) 267-1628.
